

Being the first recipient of the Employee Campaign Coordinator of the Year for 2011 was a very gratifying experience. There was great anticipation of the actual award - the opportunity to attend the 2012 United Way Community Leaders Conference in Nashville, Tennessee (USA) - and needless to say, the trip exceeded all of my expectations.

The journey was eventful from the onset with an airline delay which resulted in a missed connection flight, an unscheduled overnight hotel stay in Miami, and our arrival in Nashville a day late. However, having an excellent travel companion in UWTT's CEO Pamela Francis made the inconveniences much less painful.

Nashville is as picturesque as a travel guide magazine spread, and Southern hospitality was in abundance. The conference was hosted at the Gaylord Opryland Resort & Conference Centre. The facility was exquisite and the service impeccable.

On the first two days of the Conference, we attended ancillary business meetings specific to the International Network (Caribbean region) and I had the opportunity

to meet CEOs and Board Members of the United Way branches in Jamaica, St. Croix, St. Thomas/St. John, and Puerto Rico. I understand and support the Vision and Mission of United Way in Trinidad & Tobago and, by extension, the global organisation, but to have the opportunity to hear the regional Community Leaders share their experiences in person and the ability to contribute to the discussions was very enlightening and rewarding.

Time Favourite Guest), Seth Godin (Author and Marketing & Business Leadership Provocateur), Don Lemon (Award-winning Journalist and CNN Anchor) and many other presenters, all of whom were of such a high calibre that every session was edifying. The various learning formats were structured to meet the needs of every participant and ensured assimilation.

The Awards Dinner & 125th Anniversary Celebration was heart warming, and the Women's Leadership Council Reception & Fleur de Lis Dinner hosted by the First Lady of Tennessee at the Governor's Mansion was awe-inspiring. But, for me, the highlight of the trip was the opportunity to network with people from almost every continent. In addition to the Caribbean delegation, I networked with Community Leaders from France, Italy, Hungary, Romania, Kenya, South Africa, Nigeria, Puerto Rico, India, Japan, and various US States. It is remarkable to discover that their societal issues are no different to ours and their determination to make a difference is as intense as ours.

The effort and teamwork necessary to execute a conference of such magnitude was herculean but clearly evident because the 2012 United Way Community Leaders Conference was a resounding success. I left Nashville with an even greater appreciation of the United Way organisation on two levels:


# The Dyslexia Association

## Lindamood Phoneme Sequencing Programme

The Dyslexia Association provides specialist training for teachers in internationally recognised techniques for teaching dyslexic children and adults. Dyslexics comprise 10% - 15% of the population according to international figures. Even at a most conservative estimate this amounts to 100,000 - 150,000 dyslexics in Trinidad & Tobago.

Dyslexia can be best described as a developmental Language Learning Difficulty. All areas of language acquisition (speech, reading, writing, spelling, essay planning and even the language aspect of mathematics learning) can be affected.

For many teachers and parents the best predictor of reading success is the ability of young children to “play” with the sounds of language (phoneme awareness). However, many severely reading disabled students are unable to discriminate, separate and blend



the individual sounds of words despite adequate hearing and intelligence.

Recent Functional Magnetic Resonance Imaging (fMRI) research has shown that for some learners the area of the brain that governs this function just doesn't become engaged during these activities. This means that these students need training in the use of alternative modalities to achieve a level of

phonemic awareness necessary to become fluently literate.

The LiPS programme uses the feel and shape of the mouth to help these students develop phonemic awareness. These procedures are effective for all ages and furthermore also increase language acquisition and performance in reading and spelling.

Many remedial programmes incorporate awareness of mouth shapes to support phoneme awareness but LiPS is an in-depth auditory discrimination programme and consequently meets the needs of a significant proportion of adults and children who do not develop phoneme awareness through traditional instruction.

For the fifth year, United Way Trinidad & Tobago has committed the sum of the **\$125,000.00** to the Dyslexia Association in support of the LiPS programme that will benefit 50 teachers throughout T&T.

## CREDO Foundation for Justice

### Sophia House

Sophia House is a project of Credo Foundation for Justice, a registered non-profit organisation affiliated to the Holy Faith Sisters. Sophia House opened its doors in 2004 for the empowerment of young girls on the streets or living in abusive circumstances. It offers a haven providing love, care, attention and security and works towards re-instatement, social conformity and productive citizenship. The centre caters for girls aged 10-17 years. Like the other centres that fall under the purview of the CREDO Foundation, there is remedial help with academics, a full developmental programme, training in income-generating

skills, counselling and parent empowerment.

In 2012, United Way renewed its commitment to Sophia House by way of a grant of **\$96,000.00** to build the human resource capacity by way of two alternating developmental facilitators.

# Restoring fatherhood, rebuilding family life

The Companions of the Transfigured Christ (CTC) Community is involved in restoring fatherhood and rebuilding family life in Trinidad & Tobago and the wider Caribbean. The Community was founded in August 2000 by three young men, Kyle Dardaine, Mikkel Trestrail and Shad Seaton who had the desire to help address some of the social, moral and spiritual challenges facing young men in our society. After many years of working in Trinidad and Tobago, the community extended its work into other islands, especially in Curacao and Aruba. The community has a total of 20 members, who work alongside their staff, associates and volunteers to achieve this mission.

A major part of CTC community's mission of restoring fatherhood and rebuilding family life is achieved by reaching out to young men and other youth in need of guidance and attempting to assist them in initiating positive changes in their lifestyle and behaviour. This is done through counselling, mentoring, formation, psychological and therapeutic services with individuals and groups of any affiliation, and is executed in the form of youth and young adult outreach, retreats, developmental programmes, workshops, clinical sessions or specialty talks/lectures on related subject matters. To achieve its mission more soundly, the community established two entities: The

John Paul II Centre on Fatherhood (Est. 2009), and the Therapeutic Clinic (Est. 2010).

Through the John Paul II Centre on Fatherhood, a "Kids Inspired by Dads to Study" Programme was developed to:

- Create a homework centre with a difference, i.e. a space where children are encouraged, affirmed and assisted by current, potential and prospective fathers to complete assignments and to study. Hence the name Kids Inspired by Dads to Study (KIDS Study Centre)
- Provide a supportive environment that affirms the importance of limits, boundary setting and logic-centred approaches to academic performance and achievement. (Masculine skills set)
- Offer a co-curriculum for all our children that endorses the development of their Five Innate Human Aspects (Physical, Mental, Emotional, Social and Spiritual)
- Invite and encourage the fathers of all children involved in our KIDS Study Centre to attend our very timely and life-changing workshops for fathers

- Engage in advocacy and programme development that helps close the gap between children at our Centre and their paternal or step fathers.

As a result of the success of this programme already in operation at the John Paul II Centre, and on the request of the Rosehill RC Primary School Laventille, the centre began another KIDS programme to achieve the same objectives with 10 students of their school. With the assistance of United Way, the KIDS Programme at Rose Hill R.C. was expanded to include an additional component- the provision of group and individual therapy for the students each week by certified clinicians of the Therapeutic Clinic. Additionally, a minimum of 10 children from Rosehill R.C., Mucurapo R.C., and possibly other schools, will each year receive free clinical testing once they have successfully applied and passed the screening process.

The KIDS programme at Rose Hill R.C. School runs three days a week for one and a half hours after school in a classroom setting, with one of those days specially set aside for therapy. The programme is facilitated by the school's staff, clinicians and volunteers of our Centre, Clinic, and CTC Community. The programme has successfully completed its first term which began in April 2012.

A day's work at Rosehill R.C. will usually comprise homework, an exercise in creative thinking, confidence building, values and virtue formation with ethical reasoning, and mentoring. On therapy days dubbed "fun day", the assigned therapists for the day lead the children in an innovatively exciting way to assess, counsel and exercise their psychological work with the kids.
